1. ABOUT OUR SERVICES, LIMITATIONS

I understand this treatment is a cosmetic treatment and that no medical claims are expressed or implied. I understand the services offered are not a substitute for medical care. I understand that my esthetician is not qualified to diagnose, prescribe, or treat physical or mental illness.

Eclat Clinical Esthetics offers various services and allows booking of spa quality treatments. Treatments include but are not limited to: facials, chemical peels, Dermaflash dermaplane, mesostamping, cosmetic microneedling, microcurrent, LED light therapy, microdermabrasion. Treatments are provided by a state licensed esthetician. I understand booking requests made through the website will be confirmed or denied through email. Eclat Clinical Esthetics is not required to accept a booking request and bookings will be made at our discretion and in accordance with availability in our schedule.

2. MEDICAL HISTORY

I will notify my esthetician of all known medical and skin conditions and injuries including but not limited to: pregnancy (if so, consult your physician prior to treatment), any facial surgery, any laser treatments, dermal fillers, diseases, heart problems, pacemaker, epilepsy, allergies, tendency to develop cold sores/ fever blisters, use of chemical peels, tretinoin, Retin-A or any current or prior Accutane use, any oral prescription medications or topical prescription medications being used in the area of treatment. I understand that withholding information or providing misinformation may result in serious contraindications and/or irritation to the skin from the treatments received. Facial treatments will not be performed on clients with active cold sores and/or open wounds.

I understand there are no guarantees as to the results of any treatment, due to the many variables such as age, condition of skin, sun damage, smoking, climate, dietary and exercise habits. Facial treatments will not be performed on clients with active cold sores and/or open wounds.

3. PAYMENT AND REFUND POLICY

In the event of an appointment cancellation, there will be no charge if cancelled 24 hours prior to the appointment starting time. If the cancellation occurs less than 24 hours prior to the appointment starting time, \$25 will be charged as a cancellation fee.

4. ELIGIBILITY TO USE THE SERVICES
