SCULPLLA H2 POST CARE

1. Facial waxing is not recommended the same day as this treatment. Studies show that efficacy is better with hair left on the skin due to the fact that the Poly-L-Lactic acid absorbs through the hair follicle. You may wax 3 days before or after the treatment. If you have excessive facial hair please speak with your esthetician as the treatment involves a tight facial mask which may pull off some hair.
2. Clients must discontinue all Alpha/Beta Hydroxy Acids and active skincare products three (3) days after treatment. Examples include but are not limited to: glycolic acid, salicylic acid, Retin A, retinol, benzoyl peroxide, scrubs and facial brushes. This will help ensure penetration of the PLLA serum. Active products may dissipate the results.
3. Clients must not get the treated area wet (water, tears, saliva, sweat, steam, make up or skin care products) for twelve (12) hours after treatment. Doing so may dissipate the results.
4. No facial massage for twelve (12) hours after the treatment. Doing so may dissipate the results.
5. Clients must avoid tanning or excessive sun for 48 hours.

6. After twelve (12) hours, use only gentle (non-active) cleanser, Sculppla Stem Cell Mist and gentle moisturizer/ SPF. You may resume using your active skincare products after three (3) days. Sculppla Stem Cell Mist should be used 2-3 times per day to re-infuse skin with Poly-L-Lactic Acid between treatment.
7. Treatments must be scheduled at least seven (7) days apart but should not be scheduled more than two (2) weeks apart for best results.
8. Possible side effects include: skin redness 30 minutes to 2 hours after treatment, itching, discomfort, skin tightness and failure to achieve the desired result. If you have a history of cold sores the procedure may cause flare ups.
